## AWARENESS:

**Description of Concern:** Upfitters require Cab and Chassis electrical interface points for adding 12volt power and management for upfit equipment. Electrical access points identification.


**Warning:** Do not alter nor add upfit related electrical equipment to the vehicle Safety Systems electrical architecture.
