### AWARENESS:

**Description of Concern:** The OEM Rear Tail Lamps included with the Incomplete Chassis are only intended for Second Stage Manufacturer (Upfitter) transport use. These temporary Lamps may not meet FMVSS requirements for compliance and DOT use.

The Rear Tail Lamp circuit also includes a Rear Fog Lamp feature that should be disabled (see Mullen U.I. Bulletin #105).

**Solution:** The Second Stage Manufacturer (Upfitter) is responsible to certify the completed vehicle meets all local, state, and federal FMVSS requirements. The Upfitter must use Rear Tail Lamp units that are DOT approved and meet FMVSS requirements for a 'Completed Vehicle'.
